Memorandum of Understanding (MoU)

Entered into and concluded between



Saxion, University of Applied Sciences,
a publicly funded university established under the law of the Netherlands,
having its principal office at M.H. Tromplaan, no. 28, 7513 AB Enschede (NL),
(hereafter called "Saxion")

And



University "Haxhi Zeka"
Uçk Street, no number, 30000 Pejë/Kosovo
(hereafter referred to as 'UHZ')

In the spirit of friendship and with mutual interest in cooperation, Saxion and 'UHZ' enter into this Memorandum of Understanding (MoU) to promote collaboration in the field of education and research and agree as follows:

Article 1

The possible co-operation will be set up for education, consultancy and research. The aim is to open up the following opportunities between the above-mentioned institutions: student exchange, staff exchange, joint or double degree programmes, joint research, training and/or projects.

The terms of co-operation for each specific activity implemented under this MoU shall be discussed and agreed upon in writing by all parties prior to the initiation of that activity and will be the subject of separate written agreements.

Article 2

This agreement will not supersede any of the (legal) responsibilities of the individual Institutions.

Article 3

The Institutions will periodically discuss the activities and results of the co-operation as well as any necessary future steps. They will discuss fields of interest and will – if needed - specify the outcome of this discussion in a separate written agreement.

Article 4

This MoU shall be effective upon approval by the parties and remain in effect for four (4) years after the signing date after which it can be extended for a new period. This MoU may be revised or extended through the written agreement of the Institutions and termination may be done by any of the Institutions upon giving six months' written notice.

This MoU can only be terminated under the condition that existing obligations are completed properly.


If the introduction of the Internationalisation in Balance Act in the Netherlands results in substantial changes to the terms of this MoU, both parties have the right to suspend or dissolve the MoU. The suspension or dissolution must be in writing.

Article 5

All individual agreements and procedures between the parties must refer and adhere to this Memorandum of Understanding.
