



Memorandum of Understanding

Between Next Gen Networks – Rrjeti i Gjenerates së Re
and
University "Haxhi Zeka"

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into between Next Gen Networks – Rrjeti i Gjenerates së Re (hereinafter referred to as "NGN") with its principal place of business at St: "Mujo Ulqinaku", Nr.4, 8/2, 10000, Prishtinë, Kosovë, registration number: 5400040-5, and University "Haxhi Zeka" (hereinafter referred to as "UHZ"), with its principal place of business at Peja, collectively referred to as the "Parties".

Purpose:

The purpose of this MOU is to establish a framework for partnership and cooperation between the Parties for the joint undertaking of projects of intelligent connectivity technology, which include cyber security, 5G and others.

Scope of Cooperation:

The Parties intend to collaborate on the following areas of cooperation:

- Sharing expertise, knowledge, and resources to enhance project development and implementation.
- Conducting joint research and development activities to explore innovative solutions.
- Exchanging technical information and best practices to improve operational efficiency

Responsibilities of the Parties:

3.1) Next Gen Networks – Rrjeti i Gjenerates së Re shall:

- Provide expertise and support in relevant fields like technology and innovation.
- Contribute necessary resources, including staff and services, as agreed.
- Offer trainings and organize educational programs in collaboration with the University.

3.2) University "Haxhi Zeka" shall:

- Provide academic expertise and participate in joint activities.
- Offer access to facilities and resources for trainings and educational programs.
- Collaborate actively with NGN in organizing trainings and education initiatives.

Confidentiality:

The Parties shall maintain strict confidentiality regarding any confidential information shared during the course of this cooperation. Such information shall not be disclosed to any third party without the prior written consent of the disclosing Party, unless required by law.
